Field Activity Advisory Waters of the United States Mapping and Wetland Investigations June 3-7, 2013

The San Joaquin River Restoration Program (SJRRP), will conduct waters of the United States mapping and wetland investigations at selected locations along the San Joaquin River from Friant Dam to Merced River confluence, and Eastside Bypass in June 2013.

Who: Reclamation and ICF International, Inc.

What: Two biologists will conduct waters of the United States mapping and wetland investigations of channels and connected floodplains along portions of the San Joaquin River and the Eastside Bypass. These surveys serve to field verify aerial photograph interpretation of potential wetland and other waters of the United States mapping. Results of this data collection and analysis will allow the SJRRP to estimate baseline channel and floodplain conditions as they relate to the extents of waters of the United States. At select areas wetland data will be collected including hydrology, vegetation and soil field indicators.

Where: Surveys will primarily be conducted from public bridge crossings, wildlife refuges and ecological conservancies, and private property with permission of the landowner. Public areas scheduled for survey are identified in the below table.
